



# Youth Leader “How To” Guide

## How to enroll your congregation for the 2026 High School Gathering on Mackinac Island.

### 1. CONGREGATION ENROLLMENT

Primary Adult Leader please go to [michigandistrict.org/hsg26](http://michigandistrict.org/hsg26) to enroll. Fill in the needed information for YOUR congregation. We are asking for an approximate number of youth and adults and what your preference will be for the servant event time slot. PLEASE DO THIS AS SOON AS YOU CAN! Please do not wait until the deadline. This will ensure time for us to get you your specialized link and your parents/leaders to complete their individual enrollment online and avoid the late fee (\$50 per person)!

### 2. INDIVIDUAL ATTENDEE ENROLLMENT

You (the Primary Adult Leader - the contact on the congregation enrollment) will receive an email from the District Office (within two weeks). The email will include **YOUR congregations - specialized link** for your individual attendees to complete their enrollment, as well as a “Parent/Attendee” How to Enroll Guide. You will then email these two items to your parents/adult leaders.

- ALL Attendees (Youth or Adult) must have an enrollment completed using this specialized link.
- A Housing Form will need to be completed by the Primary Adult Leader Only for your Registered Attendees no later than May 1 at 5 p.m. You will receive instructions on how to complete your housing registration in a future communication.

### 3. DEADLINES

Congregation Enrollment deadline is April 15, 2026.

Individual Attendee Enrollment Early Bird deadline is March 31, 2026 - \$599/person

Individual Attendee Enrollment Late Registration (April 1–30) - \$649/person.

Final deadline for ALL attendee enrollments is April 30, 2026, at 5 p.m.

**Note - no cancellations or refunds after April 30.** If a cancellation is needed before April 30 contact Debbie Cameron, CMP at [debra.cameron@michigandistrict.org](mailto:debra.cameron@michigandistrict.org).

Housing form is due May 1, 2026.

Final Payment is due June 1, 2026.
